

Rider's Cycles (2011) Ltd.
Release, Waiver and Assumption of Risk

I, _____ (please print) hereby acknowledge and agree that in consideration of being permitted to participate in cycling programs, races, or activities organized, operated or sanctioned by Rider's Cycles (2011) Ltd. (herein called Rider's Cycles):

1. I do hereby release Rider's Cycles, its members, officers, directors, employees, sponsors, independent contractors, and agents from all liability, and do hereby waive as against Rider's Cycles, its members, officers, directors, employees, sponsors, independent contractors and agents all recourses, proceedings, claims, and causes of action of any kind whatsoever, in respect of all personal injuries or property losses which I may suffer arising out of or connected with my preparation for, or participation in, the aforesaid cycling activities, notwithstanding that such injuries or losses may have been caused solely or partly by the negligence of Rider's Cycles, or any of its members, officers, directors, employees, sponsors, independent contractors and agencies.
2. And, I do hereby acknowledge and agree:
 - a) that the sport of cycling can be dangerous, exposing participants to many risks and hazards, some of which are inherent in the very nature of the sport itself, others which result from human error and negligence on the part of the persons involved in preparing, organizing, and staging cycling activities;
 - b) that, as a result of the aforesaid risks and hazards, I as a participant may suffer serious personal injury, even death, as well as property loss;
 - c) that some of the aforesaid risks and hazards are foreseeable, but others are not;
 - d) that I nevertheless freely and voluntarily assume all the aforesaid risks and hazards, and that accordingly, my preparation for, and participation in the aforesaid cycling activities shall be entirely at my own risk;
 - e) that I understand that neither Rider's Cycles, nor any of its members, officers, directors, employees, sponsors, independent contractors and agents assume any responsibility whatsoever for my safety during the course of my preparation for or participation in the aforesaid cycling activities;
 - f) that I have carefully read this RELEASE, WAIVER, AND ASSUMPTION OF RISK agreement, that I fully understand same and that I am freely and voluntarily executing same;
 - g) that I understand clearly that by signing this release I will be forever prevented from suing or otherwise claiming against Rider's Cycles, its members, officers, directors, employees, sponsors, independent contractors and agents for any loss or damage connected with any property loss or personal injury I may sustain while participating in or preparing for any of the above mentioned cycling activities whether or not such loss or injury is caused solely or partly by the NEGLIGENCE of Rider's Cycles or any of its members, officers, directors, employees, sponsors, independent contractors and agents;
 - h) that I have been given the opportunity and have been encouraged to seek independent legal advice prior to signing the RELEASE, WAIVER, AND ASSUMPTION OF RISK;
 - i) that I understand clearly that Rider's Cycles would not permit me to participate in any such cycling activities unless I signed this RELEASE, WAIVER, AND ASSUMPTION OF RISK agreement, that this RELEASE, WAIVER, AND ASSUMPTION OF RISK agreement applies to all the aforesaid cycling activities whether occurring in the near or distant future, and that the terms of this Agreement need not be brought to my attention each time I participate in a cycling activity in order to be effective;
 - j) that the term cycling activity as used in this RELEASE, WAIVER, AND ASSUMPTION OF RISK agreement includes without limiting the generality of that term, activities, as well as Rider's Cycles rides, races, clinics, programs and all other events that are in any way authorized, sanctioned, organized or operated by Rider's Cycles;
 - k) that this RELEASE, WAIVER, AND ASSUMPTION OF RISK agreement is binding on myself, my heirs, my executors, administrators, personal representatives, and assigns;
 - l) that this RELEASE, WAIVER, AND ASSUMPTION OF RISK agreement may be in addition to any other release I must sign as a condition of membership in Rider's Cycles and participation in its activities and acknowledge that I am bound by the terms and conditions of both waivers.
